Housed in rack-mountable 1U hardware, it features powerful configurations such as quad-core Xeon processors, hot swappable hard drives (RAID) and are designed to support as few as 1,500 to more than 30,000 workstations while maintaining consistent and dependable service.

M86 Security solutions are installed outside the flow of network traffic in a "transparent mode," rather than "stop and check" mode, delivering zero network impact and fail-safe operation.

Single-source Provider

M86 Security "owns," designs, configures, supports and maintains every aspect of the solution. This includes the secured/hardened operating system; the Web monitoring, filtering and reporting applications; and the hardware platform. Unlike software-based solutions, M86 eliminates performance or incompatibility issues due to third-party integrations.

INTERNET CONTENT FILTERING

- **Filters the Internet:** Including URLs and/or IP addresses, HTTP, HTTPS, FTP, Newsgroups (NNTP), and TCP Ports.
- **Blocks Internet Threats:** Including spyware, malicious code, phishing sites and botnets (IRC, command-and-control).
- **Blocks Instant Messaging and Peer-to-Peer:** Utilizing M86's Intelligent Footprint Technology (IFT) to block IM and P2P servers by signature or pattern.
- **Real-Time Probes:** Allow administrators to monitor user Internet activity as it occurs.
- **"X-Strikes" Blocking:** Locks down a user's workstation when administrator defined thresholds for accessing inappropriate Web sites are exceeded.
- **Proxy-Pattern Blocking:** Block anonymous proxies using unique signature-based/pattern detection.
- **SafeSearch Enforcement:** Forces the SafeSearch mode "on" for all searches including images within search engines (Google, Yahoo, AOL, Ask, Bing).
- **Customer Feedback Module:** Sends frequent, non-categorized URLs from participating customers back to M86 Security on a daily basis. Selected URLs are reviewed and added to M86's standard library categories.
- **Synchronization Central Management Console (SCMC):** Allows administrators to synchronize and manage multiple R3000s without independently configuring each unit.
- **Multi-Tiered Administration of Active Directory and LDAP Profiles:** Administrators can define sub-administrator access control to their policy for specific AD/LDAP Groups and Users in addition to the existing control of IP Group users.
- **Detailed Internet Usage Control:** Provides the administrator the ability to block, warn, or provide a quota on Internet use.
- **Calendar-Based Time Profiles:** Time profiles can be set to the calendar by day, day of the week or day of the month. Recurrences can be configured for daily, weekly, monthly and yearly settings.

HISTORICAL FORENSIC REPORTING

- **Report Memorization, Scheduling and Distribution:** Ensures specific data inquiries can be saved or "memorized" for immediate or future access. Custom reports can be scheduled, executed and automatically distributed via e-mail at a preferred frequency (e. g. daily, weekly, monthly).
- **Archiving:** For large installations or networks that generate significant Web traffic, M86 offers attached storage solutions for collecting historical data for future inquiries.

REAL-TIME THREAT MONITORING AND REMEDIATION

- **Real-Time Threat Dashboard:** Offers up-to-the-minute graphical "gauge view" of online activity, displaying an organizational snapshot of multiple threat categories and "top offenders" based on predefined thresholds and policies. Gauges are easily customizable to monitor different groups and threats.
- **Alert Notification:** The 8e6 Alert Manager delivers automatic, predefined notifications via email, SNMP, or as an alarm in the system tray for excessive URL activity or Bandwidth usage. Alerts display information regarding the user in violation.
- **Real-Time Remediation:** Locks out policy violators or users engaging in potentially threatening activity. The lockout mechanism—activated manually or automatically—can be set to varying levels of restriction, from category lockout to complete quarantine prohibiting network access.
- **Bandwidth Management and Reporting:** Provides real-time management and monitoring of inbound and outbound bandwidth activity by protocol, port and user.
- **Trend Charting:** Displays historical trending of Web activity and Bandwidth Usage, based upon predefined categories or protocols, enabling optimization of threat gauge settings.
